

# Accessing GAIN Site Interviewer Training and Certification

Currently available to Qualified Substance Use Disorder Professionals (QSUDPs) and Qualified Substance Use Disorder Professional Trainees (QSUDPTs) employed by Business Psychology Associates (BPA) Network SUD Treatment Agencies

## Information and Instructions for Site Interviewer Trainees (SITs)

The GAIN Site Interviewer Training/Certification Process is comprised of two phases:

### 1. Didactic GAIN Site Interviewer Training Workshop

- When the GAIN Local Trainer (LT) and the GAIN Site Interviewer Trainee (SIT) are from the same substance use disorders (SUD) treatment agency, the workshop may be provided directly by the LT, or may be provided via the GAIN Site Interviewer Online Training Workshop (approximately 5 hours with a quiz at the end).
- The workshop will provide a walkthrough of the GAIN-I Assessment, addressing: background and organization; rules for doing semi-structured assessments to increase reliability and validity; a discussion of how the GAIN provides a DSM diagnosis and a level of care placement; a review of summary reports; and the protocol for becoming certified.
- When the LT and the SIT are from different SUD treatment agencies, the workshop will be provided via the GAIN Site Interviewer Online Training Workshop (approximately 5 hours with a quiz at the end).

### 2. Quality Assurance Review and Written Critique Services

- Must be provided by a certified GAIN LT
- *When using an LT outside your own agency, there will be negotiated costs associated with the LT providing QA Reviews and Written Critique services that must be paid by the SIT or his/her employer.*

**Instructions to begin the GAIN certification Process:**

- Contact the LT from your own agency or from the list on the following page.

*Contact your LT immediately if you have questions or if there is an anticipated delay in completing certification by the target date. If you are administering the GAIN-I to live clients on GAIN ABS, your access permission ends at the 90-day target date for certification, if certification is not yet complete.*
