

## WITS Changes – 17.19.3 Release (SUD)

6/12/2015

In the 17.19.3 Release 3 bugs were repaired in WITS. Below are a summary of the errors and the resolutions of the problems.

- 1) Tx Plan/Plan of Care - No 'Mark as Principal' option for Edit Diagnosis. **Resolution:** Added 'Mark as Principal' option for Edit Diagnosis which is under the Plan of Care.
- 2) H835: Timeout when trying to delete. **Resolution:** H835 file can now be deleted without any issues.
- 3) Claim Item List: Getting yellow screen error when rejecting Cost Reimbursement FFS-E claim. **Resolution:** Yellow Screen Error when rejecting Cost Reimbursement FFS-E-Claim has been resolved.

Below you will find a summary of the change to WITS for the 17.19.3 release (which took place June 16, 2015). When these changes are made in Idaho-Mountain and Idaho-Pacific, the top left portion of your screen will say 17.19.3.

### Accessibility

NOTE: JAWS, Job Access With Speech, is a 3<sup>rd</sup> party screen reader, developed for computer users whose vision loss prevents them from seeing screen content or navigating with a mouse.

The left WITS navigation menu is now compatible with JAWS using the following keystroke functionality:

- HOME takes you to the first menu node.
- END takes you to the last menu node.
- Up and Down arrow keys take you from one menu node to the next.
- Left and Right arrow keys collapse or expand sub-menus.
- Letter keys take you to the nearest menu node that starts with that letter.

The move over boxes (dual-list/multi-select boxes) throughout the system are now compatible with JAWS.

The WITS List screen Actions columns are now compatible with JAWS. The TAB key will shift focus from each action to the next within the Actions pencil icon pop-up menu.

The following screens are now compatible with JAWS:

- Client Profile (all screens)
- Client Group Enrollment
- Authorization
- Intake
- Admission

- Periodic Assessment
- Encounter Notes
- Miscellaneous Notes
- Diagnosis
- Treatment Plan/Review

## Group

The "End Date" and "# of Units" fields have been added to the Group Session Profile screen to support Unit based date spannable services. These will capture the same data as on the Encounter screen and will populate on encounters created from the Group Session.
